Through the Community Impact Model, UWSC focuses on the area of financial stability. Based on recommendations from our Community Change Team members, UWSC provides financial support to 17 affiliated programs at 12 local organizations. Additionally, UWSC facilitates several Community Impact Programs that aim to reach goals in the same focus area. As a result of this strategy, UWSC plays a greater leadership role, facilitates programs, shares more resources and is more focused and inclusive.**

**Project HOME provides assistance with homelessness prevention and rapid re-housing. It assists in identifying gaps in services and evaluating the performance of member agencies in providing emergency transitional and permanent housing to meet the needs of the community. The COVID Emergency Rental Assistance program assists renters with rent arrearage, future rent and utilities.**
